#### **CO-PRESIDENT'S REPORT**

**T**t has been a few months since the last **⊥**newsletter and much has happened in the country and LAGPA. In San Francisco, marriage licenses were issued to Gay and Lesbian couples and the first marriages between same gender partners were performed. Soon thereafter, marriage licenses were issued in New Paltz, New York, Albuquerque, New Mexico and cities in other states. Though the courts have placed an injunction on the issuance of new same-sex couple marriage licenses, hundreds of Gay and Lesbian couples are now married and the courts will have to look into the faces of real people, who love each other, before deciding on the legality of the issue. George W. Bush's bigotry and desire to disenfranchise a specific group of people became undeniably clear when he stated he would support a constitutional amendment to ban same gender marriages.

For a United States President to suggest the proposal of an amendment to the Constitution that would clearly deny rights to a specific group of US Citizens is an historic move. It appears that those who oppose Gay/Lesbian marriages are coming from a place of fear related to a threat to their sense of self and ego strength. Though there are still other disenfranchised groups of people living within the United States and there have been many atrocities committed against specific groups in U.S. history, fueling and inflaming the desire to perpetrate segregation and hatred should not be the road taken by the person swore to uphold the Constitutional principles of "equality and

justice for all." Further, to call judges who are actually interpreting and adhering to the laws as written "rogues" undermines the judicial system under which we live. It will be interesting to see how this plays out in the courts and what impact it has on the November elections.

Back in LAGPA's little corner of the country, we have had some Board, **Executive Committee and Conference** Committee changes. Due to a number of personal difficulties, Claudia Bramlett had to resign as Treasurer, Board Member and Conference Committee Chair. Claudia had been LAGPA treasurer for two years, and served on the board and a number of committees. Thank you Claudia for all you contributed. You will be missed and we hope you will be back when things calm down. Our new treasurer is Dr. Paula Newman. In addition to her Psy.D., Paula has a degree in business and has agreed to take on the daunting task of managing our finances. Dr. Harry Drasin has stepped in to help Bill Mochon co-chair the Conference Committee. Claudia's departure has left us with another hole in the Board and we need three female and three male Board members.

#### CYBERSEX CEU SEMINAR

The Board would like to thank Doug Braun-Harvey, MFT for presenting an interesting and enlightening CEU seminar on March 12, 2004 entitled "Culturally Relevant Assessment and Treatment for Gay Men's Online Sexual Activity." Over 25 people took part in the seminar which consisted of a lecture, Q&A and discussion. Doug has been a practicing therapist in the San Diego Gay and Lesbian Community for over 20 years, and is regarded as an expert in the treatment of sexual dependency and addiction.

Mr. Braun-Harvey initially outlined some elements of sexual health which include:

- The capacity to enjoy and control sexual and reproductive behavior in accordance with a social and personal ethics
- Freedom from factors that inhibit sexual response and sexual relationships, including fear, shame, guilt, false beliefs, and other psychological influences

In the rapists to have a positive approach to human sexuality and help clients integrate the somatic, emotional, intellectual and social aspects of sexuality into their personalities and daily lives. He defined "sexual dependency" as sexual behaviors that involve problems of sexual control, and excessive, intrusive sexual preoccupation leading to psychological distress. Any sexual behavior can become a source of harmful dependence. Sexual dependency includes a ritualistic, repetitive, rigid set of behaviors that require professional treatment and compassionate understanding from well-informed clinicians.

Mr. Braun-Harvey cited the use of the Internet as an important cultural/social phenomenon for all therapists to be aware of

as it has enabled the general public to have easy access to sexually related products, services and encounters. Gay and bisexual men are especially skillful and likely to use the Internet for a variety of such purposes. He made several points about gay men and the Internet, notably:

- Gay men access the internet at a higher frequency and a higher proportion than most any other demographic group.
- Gay men with access to the internet will most likely express some aspect of their sexuality via online sexual activity.
- The more disenfranchised the sexual interest, the more advantages the internet may have for making contact with persons of similar interest.

**✓**r. Braun-Harvey said psychotherapists **L**working with gay men must have knowledge of the world of online sexual behavior as well as specific online behavior patterns commonly present in the lives of gay men. Assessment of gay men's online activity is the all-important first step for therapists. In order to distinguish the type of activity a therapist must ask specific and detailed questions that elicit the specific details of the type of online activity in which the client engages. Moreover, the therapist must explore the meaning and purpose the online activity has for the client. The audience was cautioned to be respectful, reasonable and thoughtful in questioning clients about their online sexual behavior. A premature focus on the client's online sexual behavior being problematic, excessive or out-of-control may be misperceived by the client as a sex negative attitude about on-line sexual behavior.

### PSYCHOANALYTIC CASE STUDY WITH A GAY COUPLE SEMINAR

On Friday evening, February 6, Jim Green, Ph.D., Psy.D., gave an engaging presentation as part of LAGPA's continuing education series. He spoke about his long-term, psychoanalytic therapy with a gay male couple, raising a number of interesting issues and stimulating a lively discussion among the, approximately, 30 people in attendance. Dr. Green is a Training and Supervising Analyst and a graduate of the Institute of Contemporary Psychoanalysis and he works primarily from an Intersubjective orientation.

Dr. Green presented material from his sessions with this couple and discussed his understanding of the unconscious dynamics at play in the their interactions. It was refreshing to hear Dr. Green openly discuss his countertransference reactions in working with the couple and how these reactions guide him in his interventions. The group discussion lasted almost 45 minutes following Dr. Green's presentation. Everyone in the room appeared to have something to say. Issues/ questions raised by the seminar attendees included the extent to which therapy with gay male couples was different from work with other couples, how issues of transference and

There was also quite a bit of discussion about the couple's agreement to allow sex outside of the relationship.
