



#### 4. FULL NINTH CIRCUIT COURT OF APPEALS UPHOLDS SB1172

#### This a note sent to our Treasure Travis Stobbe about SB1172. Great news!

Dear Travis,

Victory! On Wednesday, the full Ninth Circuit Court of Appeals agreed that California can ban the outdated and dangerous attempts to change the sexual orientation of minors.

It was another victory for lesbian, gay, bisexual and transgender kids in California, and makes it easier for other states — like New Jersey — to defend their own bans on this discredited and discriminatory pseudoscience.



We are proud to have sponsored and defended this important law. We are grateful to Senator Ted Lieu for authoring it and to Governor Brown for signing it.

We wouldn't have won without the impressive support of California Attorney General Kamala Harris, as well as the excellent representation in court from the National Center for Lesbian Rights and the law firm of Munger, Tolles, & Olson LLP.

We are also grateful for medical and mental health associations that supported the law and helped to educate the legislature about the serious dangers posed by scientifically baseless efforts to change a person's sexual orientation or gender expression. No ethical professional should put a young person's life and well-being at risk by

engaging in these ineffective and dangerous practices. Every young person deserves to be treated with dignity and respect and to be valued for who they are.

Finally, we're also grateful to the support of all of you, our members. Without your passionate advocacy, this bill might never have become law. This is our victory, together, and we should all be proud.

#### 5. AIDS FUNDING CUTS

## What is happening to HIV prevention in Los Angeles?

In 16 days, HIV prevention services are going to be cut off from funding for 3 months. What is going to be done to backfill these services to prevent clients from falling through the cracks? What about syringe exchange, which can't be funded with federal (Ryan White) dollars? Are we going to stand up for our prevention programs, or are we going to wait and see what government decides?

#### THE SITUATION:

Starting April 1 – in 16 days there will be no program funding from the LA City AIDS Coordinator's Office. There may be funding available for services starting July 1, but so far they have only identified 57% of what they need to provide existing services.

There will be no funding for any of these programs from the CAO when their contracts end March 30th. After July 1 they only have 57% of the budget covered – so even if the City Council covers this gap – we are still facing a 43% reduction in direct services starting July 1.

They are the only ones funding syringe \*disposal\* because they can't fund the exchange part in LA City Limits. LA County supports a number of approved sites outside of the City of LA.

#### THE FORMAL RESPONSE:

Request that City Council cover 3 month budget gap from April 1 through July 1. Reinstate funding at the same level starting July 1.

#### 6. THE ADVOCACY GOES ON—CAMFT REFUSAL TO STATE SOCE IS UNETHICAL.

This is a note from Jim Walker, MFT about CAMFT.

Please take a couple minutes to sign this petition asking CAMFT to change their Code of Ethics to clearly state that "ex-gay" or "reparative" practices are unethical. http://www.convertmfts.org/

The backstory: In 2010, a tiny a group of CAMFT members advocated with CAMFT that they change their code of ethics to ban to these practices, which are also called SOCE. CAMFT finally issued a statement in 2012 about SOCE but they did not ban it for their members as the American Counseling Association and NASW have.

Also in 2012, LAGPA and Gaylesta helped pass a law protecting youth from SOCE. CAMFT did not oppose the legislation, neither did they support it like other professional associations did—although a handful of the larger CAMFT chapters supported the legislation.

As soon as the law took effect in 2013, several therapists—among them David Pickup, MFT, a CAMFT member--challenged the law in court. Each time the courts ruled in support of the law, Mr. Pickup and other therapists appealled the judges' decisions.

This year we've learned Mr. Pickup continues trying to take down the new law. A very conservative Christian legal group has helped Mr. Pickup ask the U.S. Supreme Court to hear his appeal to overturn the law. As of this posting, the Supreme Court hasn't decided if they will hear their appeal or if they will let the lower court's decision stand, which would finally put the new law in effect once and for all.http://www.courthousenews.com/2014/02/04/65092.htm

Mr. Pickup and other therapists not only use these harmful practices on clients. They also teach SOCE to other therapists so they can also inflict them on others. That's double the reason why CAMFT needs to declare that such practices are unethical for their members. http://www.reorientationtherapy.com/?page\_id=8

This year a group of MFT students at the Wright Institute in Berkeley lead by Beth Greivel launched this petition. You have to admire their advocacy for protecting the public from these ineffective and harmful practices.



#### 7. RICK WARREN AT SADDLEBACK CHURCH

A Note from Sarah Wood:

I would appreciate the assistance of mental health professionals in protesting the co-sponsorship of the National Alliance on Mental Illness Orange County at the "Gathering on Mental Illness and the Church" scheduled for March 28 at Rick Warren's Saddleback Church in Lake Forest, CA.

We implore the National Alliance on Mental Illness Orange County not to co-sponsor the "Gathering on Mental Health and the Church" with Saddleback Church and the Roman Catholic Diocese of Orange, both of whom promote religiously sanctioned bigotry and oppression. Their consistent anti-women and anti-gay rhetoric contributes to additional anguish for women and sexual and gender minorities with mental illness and is in direct opposition to the stated goal of this conference.

Rick Warren and Saddleback Church adhere to the belief that faith supercedes science. History shows we ignore their faith-based positions at great peril to public health and safety, human rights, and civil society. Your partnership with them signals you sanction their faith-based positions, further endangering the most fragile and oppressed members of our communities.

Evangelicals hold and promote their own events on everything from mental illness to dieting in order to maintain their "integrity." If you search the websites promoting "The Gathering on Mental Health and the Church," you will see they all present homosexuality as sin. It is something to "struggle with" and "overcome." This "Biblical World View" on homosexuality is a key differentiator from the secular world. All of the websites also promote restricting women's access to reproductive health care, something of grave concern to anyone who cares about women's mental health.

## More background:

Tragically, in April 2013, Matthew Warren committed suicide after a long and painful struggle with mental illness. Matthew was the son of Rev. Rick Warren, bestselling author of "The Purpose Driven Life." In response, Rev. Warren and his wife Kay plan to increase awareness about mental illness in the church by convening a "Gathering on Mental Health and the Church" at Saddleback Church in Lake Forest, CA on March 28, 2014.

For decades, conservative churches have lagged behind the scientific and medical community in diagnosing and treating mental illness, often discouraging the use of effective psychiatric medications and promoting prayer as a primary treatment. Rev. Warren wants to move the ball forward by equipping the church to respond more helpfully to persons afflicted with mental illness. He is encouraging treatments recognized as effective by scientifically-based psychiatric and psychological associations. That is a respectable goal.

Unfortunately, Rev. Warren also has a long history of making internationally broadcasted statements sanctioning religious intolerance and bigotry that compound mental health problems afflicting girls, women, and sexual and gender minorities (lesbians, gays, bisexuals, transgender, queer, and intersex).

Rev. Warren consistently cites the Bible as his "source of authority." To Rev. Warren, Biblical truths supersede verifiable facts. He stubbornly supports teaching intelligent design and abstinence-only sex education despite damning critiques from the scientific community. Many credit his insistence on eliminating the promotion of condom usage in Uganda with reversing the decline in HIV infection in

that country. Rev. Warren strongly discourages divorce other than in the most extreme cases of abuse, imperiling men and women in emotionally abusive marriages.

For decades, Rev. Warren has called homosexuality a sin. In media interviews, Warren has equated homosexuality with bestiality, pedophilia, incest, consuming arsenic, "punching a guy in the face," and the painful betrayal of adultery. Many credit Rev. Warren's high-profile leadership in Africa calling homosexuality "unnatural" with preparing the homophobic foundation for extreme anti-gay legislation and anti-gay rhetoric that has engulfed several African countries. Rev. Warren stated that he would maintain his anti-gay positions regardless of scientific evidence, because he trusts the truth of the Bible. Most recently, Rev. Warren lent his voice to framing anti-gay legislation in the United States in terms of "religious liberty."

Saddleback Church is affiliated with the Southern Baptist Convention, an organization that actively promotes anti-gay legislation and "pro-life" public policies denying even rape and incest victims access to the morning-after pill. They laud patriarchal family structures, insisting that wives submit to their husbands "as to the Lord." Several of the proposed speakers at the "Gathering on Mental Illness and the Church" are affiliated with the Southern Baptist Convention, further increasing the likelihood that faith-based sexist and heterosexist stereotypes will go unchallenged.

The Roman Catholic Diocese of Orange is the other co-sponsor of the conference. The Roman Catholic Church also rejects the conclusions of the scientific and medical communities regarding homosexuality, characterizing it as "disordered." Like the Southern Baptists, Roman Catholics institutionalize sexism by refusing to ordain women and institutionalize heterosexism by refusing to marry gay couples. Like Rev. Warren, they promote celibacy as a solution to homosexuality, a "treatment" not encouraged by the scientific and medical community. Rev. Warren supports the efforts of the Catholic Church to deny girls and women access to contraception – a vital resource for girls and women suffering from mental illness.

Partnering with ostensibly secular organizations is a well-worn tactic of Rev. Warren and Saddleback Church. He and his members are constantly seeking participation in their events and organizations from civic organizations, public schools, and other secular non-profits. Rev. Warren then leverages those relationships to beef up his reputation as a moderate. That means more prostletizing, increased membership, more donations, and greater global influence. In all of his activities, both locally and internationally, Rev. Warren only funds and supports individuals and institutions who uphold (or "respect") his anti-gay, anti-women positions. Please help me contain his influence.

Steve Pitman is the sole scheduled speaker for NAMI OC at the Gathering. He is the President of the Board of Directors. The "Gathering on Mental Health and the Church" is not being promoted through reputable psychological associations, but rather through Christian websites, radio stations, etc. Rick Warren's current position is that "homosexuality may or may not be a sin, but, homosexual behavior is a sin because sex outside of marriage is a sin, and marriage is between one man and one woman."

#### Addendum:

How can you "de-stigmatize" mental illness while stigmatizing people who deal with mental health issues BECAUSE of the stigma levied against them by fundamentalist religious preachers? Are the suicides of gay children due to the self-hatred caused by preachers such as Rick Warren any less important than the suicide of this preacher's own son? Why was his son "ok with God" and other people's sons "not ok with God" due to their sexual orientation? Is NAMI just going to "forget" about this group of people they claim to serve merely because they are speaking at a fundamentalist church? Would NAMI speak at a white's only church? Would they forget the discrimination and harm to people of color in the name of publicity? I think not. How is this any different? They are being used as pawn in the great game orchestrated by Rick Warren and Saddleback Church. Their participation in this is unprofessional, immoral, and goes against the very tenants they claim to espouse. NAMI should withdraw from the conference publicly or make a public statement before, during and after the meeting that they do not agree with Warren's stance on LGBTQ issues. Anything short of these actions constitutes a breach in trust between NAMI and the LGBTQIA community. Their reputation should bear the consequences of their action or inaction.






